

Information on entities of the national economy entered in the REGON register - February 2024

An increase in the number of newly registered entities in relation to the previous month

As at the end of February 2024 the REGON register included 5 174.6 thous. of national economy entities. The number of newly registered entities in February amounted to 38.8 thous., i.e. by 12.2% more than a month before.

Newly registered entities in the REGON register

The number of newly registered entities increased in February (by 12.2%) compared to the previous month. The increase in the number of newly registered entities was noted in the section other service activities, in particular in the scope of activities classified in the division: activities of membership organizations.

Deregistered entities from the REGON register

In February, 19.1 thous. entities were deregistered from the REGON register, i.e. by 33.0% less than in the previous month. There was a decrease in the number of deregistered civil law partnerships (by 40.9%) and commercial companies (by 3.3%). The number of deregistered natural persons conducting economic activity decreased (by 37.0%).

Entities with suspended activity in the REGON register

Entities with suspended activity according to the REGON register at the end of February accounted for 14.7% of the total number of registered entities. An increase in the number of entities with suspended activity (by 0.6%) compared to the previous month was recorded. An increase in the number of entities with suspended activity was recorded in the section arts, entertainment and recreation activities (by 1.7%), information and communication (by 1.6%), professional, scientific and technical activities (by 1.3%).

Chart 1. The number of newly registered entities entered in the REGON register

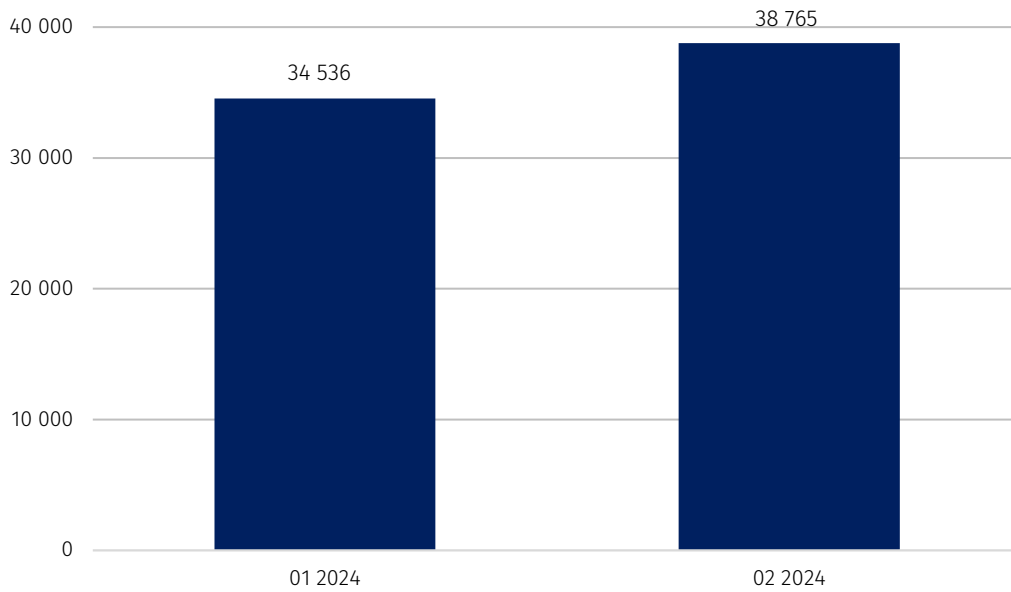


Chart 2. The number of newly registered and deregistered entities in the REGON register by PKD sections in February 2024

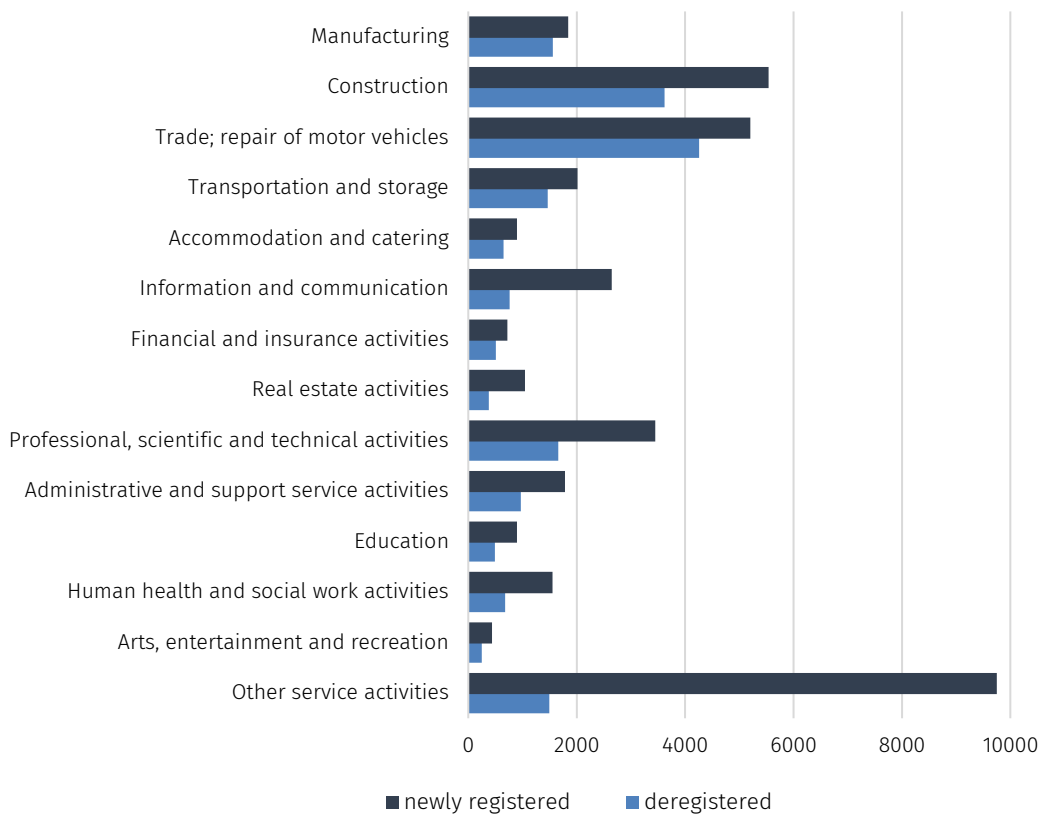
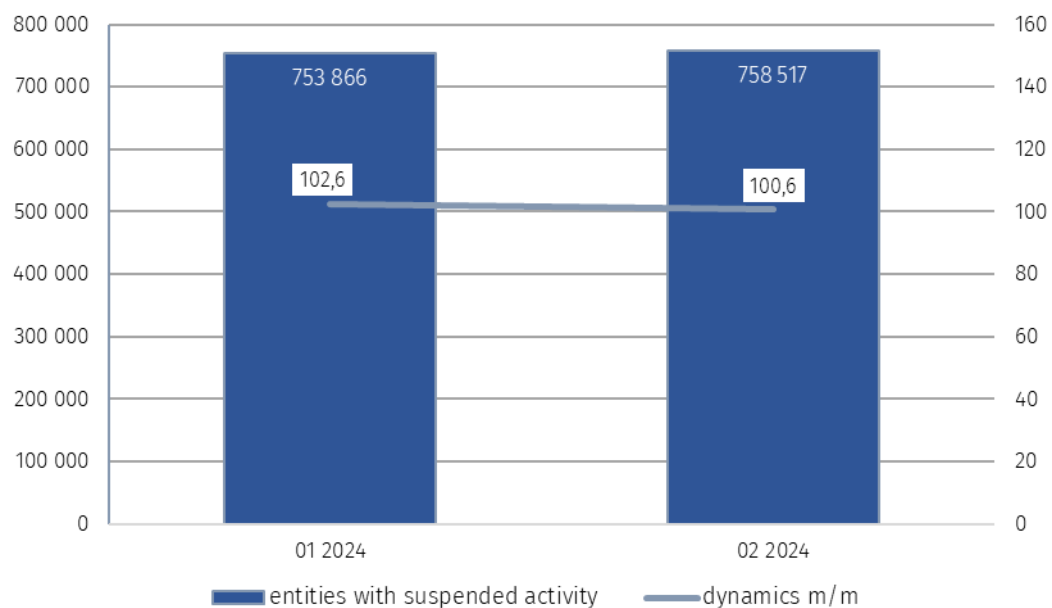


Chart 3. The number of entities with suspended activity in the REGON register
